Introductory note

This introductory note does not form a part of the notice.

The following notice gives notice of the variation of an environmental permit.

The variation varies the permit from standard rules SR2010 No16, on-farm anaerobic digestion facility including use of the resultant biogas, to standard rules SR2012 No9, on-farm anaerobic digestion facility using farm waste only, including use of the resultant biogas. The SR2012 No9 is available to operators with an anaerobic digestion capacity of over 100 tonnes of waste per day. This is to bring the site in compliance with the 2013 amended Environmental Permitting Regulations following the introduction of the Industrial Emissions Directive.
