## Standard rule permit

We have decided to grant the permit for an IBA Recycling Facility operated by Raymond Brown Minerals and Recycling Ltd.

The permit number is EPR/LP3239AW

We consider in reaching that decision we have taken into account all relevant considerations and legal requirements and that the permit will ensure that the appropriate level of environmental protection is provided.
